Since 2013, we have been dedicated to creating brighter tomorrows for children in our community and caring for abandoned, vulnerable, and special needs children.

Our Initiatives

Under the Likhon iThemba umbrella, we run four life-changing projects:

- **HOLAH (House of Love and Hope) Baby Home and Special Needs Home** - A registered Place of Safety. Since June 2013, we have cared for more than 150 babies and children. Currently, we care for 16 children between the ages of 2 and 13 years. Of these, 10 have special needs and will remain in our long-term care, while the others are placed for foster care, adoption, or reunification with family members.
- **Bowl of Plenty Feeding Scheme** - Providing weekly meals to 120 children in Molweni, KwaZulu-Natal, ensuring food security and nutritional support.
- **Vikela Baby Saver** - A specialised receptacle for the safe and anonymous relinquishment of babies, offering desperate mothers an alternative to unsafe abandonment. Our Baby Saver site is located in Molweni.
- **Charity Hop Shop** - An income-generating project that contributes approximately 16% of our monthly operating costs while offering affordable goods to the community.

At Likhon iThemba, our mission is to stand in the gap for vulnerable children — caring for them today while fighting for the opportunities and futures they deserve tomorrow.
